Subject: Adjusted Tempest Therapeutics, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: TPST1

Adjusted Tempest Therapeutics, Inc. options were adjusted on April 9, 2025 (See OCC Information Memo #56323). The new deliverable became 1) 7 Tempest Therapeutics, Inc. (TPST) Common Shares and 2) Cash in lieu of approximately 0.6923 fractional TPST Shares. Only settlement of the cash portion of TPST1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$8.05714 per whole TPST share will be used to determine the cash in lieu amount at a rate of 0.6923. Accordingly, the cash in lieu amount is:

$$0.6923 \times \$8.05714 = \$5.58 \text{ per TPST1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 9, 2025 through April 14, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the TPST1 options are as follows:

New Deliverable

Per Contract: 1) 7 Tempest Therapeutics, Inc. (TPST) Common Shares
2) \$5.58 Cash

Strike Prices: Unchanged

CUSIP: TPST: 87978U207

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The TPST component of TPST1 exercise/assignment activity from April 9, 2025 through April 11, 2025, has settled through National Security Clearing Corporation (NSCC). The \$5.58 cash amount will be settled by OCC.

Pricing

The underlying price for TPST1 will be determined as follows:

$$\text{TPST1} = 0.07 (\text{TPST}) + 0.0558$$

For example, if TPST closes at 6.22, the TPST1 price would be calculated as follows:

$$\text{TPST1} = 0.07 (6.22) + 0.0558 = 0.49$$
