Subject: SolarWinds Corporation - Cash Settlement/Acceleration of Expirations Option Symbol: SWI Date: 04/16/2025

On February 7, 2025, the Principal Stockholders, which owned approximately 65% of the aggregate voting power of the issued and outstanding shares of SolarWinds Corporation (SWI), delivered written consent approving the merger agreement between SWI and a wholly owned subsidiary of Starlight Parent, LLC, which are both affiliates of the private equity investment firm Turn/River Capital, L.P. The merger was subsequently consummated before the open on April 16, 2025. As a result, each existing SWI Common Share will be converted into the right to receive \$18.50 net cash per share.

Settlement in SWI options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SolarWinds Corporation options whose expiration dates are after 05-16-2025 will have their expiration dates advanced to 05-16-2025. Expiration dates occurring before 05-16-2025 (e.g., Flex options) will remain unchanged.

All SolarWinds Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: SWI Existing Expiration: All months New expiration date: 05-16-2025 Existing American-style SolarWinds Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
