Adjusted Fomento Economico Mexicano, S.A.B. de C.V. (adjusted option symbol FMX1) options were adjusted on January 17, 2025 (See OCC Information Memo #55973). The new deliverable became 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) \$33.28 Cash.

Fomento Economico Mexicano, S.A.B. de C.V. (FMX) has announced an Extraordinary Cash Dividend of approximately \$1.256089, less fees and withholdings, if any, per FMX American Depositary Share. The record date is April 24, 2025; payable date is May 5, 2025. The ex-distribution date for this distribution will be April 24, 2025.

Adjusted Fomento Economico Mexicano, S.A.B. de C.V. options will be further adjusted as described below:

Until the final net cash dividend amount is determined, the underlying price for FMX1 will be determined as follows:

$$\text{FMX1} = \text{FMX} + 1.5889$$

Delayed Settlement

The FMX component of the FMX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FMX1 deliverable until the exact cash amount is determined. Upon determination of the exact cash amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
