On April 1, 2025, Shareholders of Patterson Companies, Inc. (PDCO) voted concerning the proposed merger with a wholly owned subsidiary of Paradigm Parent, LLC, which are both subsidiaries of funds managed and advised by Patient Square Capital, L.P. The merger was approved and subsequently consummated before the open on April 17, 2025. As a result, each existing PDCO Common Share will be converted into the right to receive \$31.35 net cash per share.

Settlement in PDCO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Patterson Companies, Inc. options whose expiration dates are after 05-16-2025 will have their expiration dates advanced to 05-16-2025. Expiration dates occurring before 05-16-2025 (e.g., Flex options) will remain unchanged.

All Patterson Companies, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Patterson Companies, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
