Subject: Adjusted Scilex Holding Company – Cash In Lieu Settlement
Adjusted Option Symbol: SCLX1

Adjusted Scilex Holding Company options were adjusted on April 15, 2025 (See OCC Information Memo #56352). The new deliverable became 1) 2 Scilex Holding Company (SCLX) Common Shares and 2) Cash in lieu of approximately 0.8571 fractional SCLX Shares. Only settlement of the cash portion of SCLX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$6.60 per whole SCLX share will be used to determine the cash in lieu amount at a rate of 0.8571. Accordingly, the cash in lieu amount is:

$$0.8571 \times \$6.60 = \$5.66 \text{ per SCLX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 15, 2025 through April 23, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the SCLX1 options are as follows:

New Deliverable

Per Contract: 1) 2 Scilex Holding Company (SCLX) Common Shares
2) \$5.66 Cash

Strike Prices: Unchanged

CUSIP: SCLX: 80880W205

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The SCLX component of SCLX1 exercise/assignment activity from April 15, 2025 through April 22, 2025, has settled through National Security Clearing Corporation (NSCC). The \$5.66 cash amount will be settled by OCC.

Pricing

The underlying price for SCLX1 will be determined as follows:

$$\text{SCLX1} = 0.02 (\text{SCLX}) + 0.0566$$

For example, if SCLX closes at 3.99, the SCLX1 price would be calculated as follows:

$$\text{SCLX1} = 0.02 (3.99) + 0.0566 = 0.14$$
