**Subject:** Adjusted Forge Global Holdings, Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: FRGE1

Adjusted Forge Global Holdings, Inc. options were adjusted on April 15, 2025 (See OCC Information Memo #56359). The new deliverable became 1) 6 Forge Global Holdings, Inc. (FRGE) Common Shares and 2) Cash in lieu of approximately 0.6667 fractional FRGE Shares. Only settlement of the cash portion of FRGE1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$9.2925 per whole FRGE share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$9.2925 = \$6.20 \text{ per FRGE1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 15, 2025 through April 28, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the FRGE1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 6 Forge Global Holdings, Inc. (FRGE) Common Shares  
2) \$6.20 Cash

**Strike Prices:** Unchanged

**CUSIP:** FRGE: 34629L202

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The FRGE component of FRGE1 exercise/assignment activity from April 15, 2025 through April 25, 2025, has settled through National Security Clearing Corporation (NSCC). The \$6.20 cash amount will be settled by OCC.

## **Pricing**

The underlying price for FRGE1 will be determined as follows:

$$\text{FRGE1} = 0.06 (\text{FRGE}) + 0.0620$$

For example, if FRGE closes at 12.71, the FRGE1 price would be calculated as follows:

$$\text{FRGE1} = 0.06 (12.71) + 0.0620 = 0.82$$
