**Subject:** Adjusted MicroCloud Hologram Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: HOLO1

Adjusted MicroCloud Hologram Inc. options were adjusted on April 21, 2025 (See OCC Information Memo #56376). The new deliverable became 1) 2 MicroCloud Hologram Inc. (HOLO) Ordinary Shares and 2) Cash in lieu of 0.5 fractional HOLO Shares. Only settlement of the cash portion of HOLO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$12.20 per whole HOLO share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$12.20 = \$6.10 \text{ per HOLO1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 21, 2025 through April 28, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the HOLO1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 2 MicroCloud Hologram Inc. (HOLO) Ordinary Shares  
2) \$6.10 Cash

**Strike Prices:** Unchanged

**CUSIP:** HOLO: G55032174

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The HOLO component of HOLO1 exercise/assignment activity from April 21, 2025 through April 25, 2025, has settled through National Security Clearing Corporation (NSCC). The \$6.10 cash amount will be settled by OCC.

## **Pricing**

The underlying price for HOLO1 will be determined as follows:

$$\text{HOLO1} = 0.02 (\text{HOLO}) + 0.0610$$

For example, if HOLO closes at 12.33, the HOLO1 price would be calculated as follows:

$$\text{HOLO1} = 0.02 (12.33) + 0.0610 = 0.31$$
