Subject: Adjusted Tvardi Therapeutics, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: TVRD1

Adjusted Tvardi Therapeutics, Inc. (formerly Cara Therapeutics, Inc.) options were adjusted on December 31, 2024 and on April 16, 2025 (See OCC Information Memos #55912 and #56366). The new deliverable became 1) 2 Tvardi Therapeutics, Inc. (TVRD) Common Shares, 2) Cash in lieu of approximately 0.6667 fractional TVRD Shares, and 3) \$1.74 Cash. Only settlement of the cash portion of TVRD1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$16.38 per whole TVRD share will be used to determine the cash in lieu amount at a rate of 0.6667. Accordingly, the cash in lieu amount is:

$$0.6667 \times \$16.38 = \$10.92 \text{ per TVRD1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 16, 2025 through April 29, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the TVRD1 options are as follows:

- 1) 2 Tvardi Therapeutics, Inc. (TVRD) Common Shares
- 2) \$12.66 Cash (\$10.92 + \$1.74)

Strike Prices: Unchanged

CUSIP: TVRD: 140755307

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The TVRD component of TVRD1 exercise/assignment activity from April 16, 2025 through April 28, 2025, has settled through National Security Clearing Corporation (NSCC). The \$12.66 cash amount will be settled by OCC.

Pricing

The underlying price for TVRD1 will be determined as follows:

$$\text{TVRD1} = 0.02 (\text{TVRD}) + 0.1266$$

For example, if TVRD closes at 21.02, the TVRD1 price would be calculated as follows:

$$\text{TVRD1} = 0.02 (21.02) + 0.1266 = 0.55$$
