**Subject:** Adjusted X4 Pharmaceuticals, Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: XFOR1

Adjusted X4 Pharmaceuticals, Inc. options were adjusted on April 28, 2025 (See OCC Information Memo #56447). The new deliverable became 1) 3 X4 Pharmaceuticals, Inc. (XFOR) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional XFOR Shares. Only settlement of the cash portion of XFOR1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$5.34 per whole XFOR share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$5.34 = \$1.78 \text{ per XFOR1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 28, 2025 through May 05, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the XFOR1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 3 X4 Pharmaceuticals, Inc. (XFOR) Common Shares  
2) \$1.78 Cash

**Strike Prices:** Unchanged

**CUSIP:** XFOR: 98420X202

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The XFOR component of XFOR1 exercise/assignment activity from April 28, 2025 through May 2, 2025, has settled through National Security Clearing Corporation (NSCC). The \$1.78 cash amount will be settled by OCC.

## **Pricing**

The underlying price for XFOR1 will be determined as follows:

$$\text{XFOR1} = 0.03 (\text{XFOR}) + 0.0178$$

For example, if XFOR closes at 3.73, the XFOR1 price would be calculated as follows:

$$\text{XFOR1} = 0.03 (3.73) + 0.0178 = 0.13$$
