Delayed Settlement

The COF component of the COF1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the COF1 deliverable until the cash in lieu of fractional COF shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On February 18, 2025, Shareholders of Discover Financial Services (DFS) voted concerning the proposed merger with Capital One Financial Corporation (COF). The merger was approved and subsequently consummated before the open on May 19, 2025. As a result, each existing DFS Common Share will be converted into the right to receive 1.0192 COF Common Shares. Cash will be paid in lieu of fractional COF shares.
