Subject: Adjusted Acelyrin, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: ALMS1

Adjusted Acelyrin, Inc. options were adjusted on May 21, 2025 (See OCC Information Memo #56592). The new deliverable became 1) 48 Alumis Inc. (ALMS) Common Shares and 2) Cash in lieu of 0.14 fractional ALMS Common Shares. Only settlement of the cash portion of ALMS1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.8422 per whole ALMS share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.14 \times \$4.8422 = \$0.68 \text{ per ALMS1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of May 21, 2025 through June 03, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the ALMS1 options are as follows:

New Deliverable

Per Contract: 1) 48 Alumis Inc. (ALMS) Common Shares
2) \$0.68 Cash

Strike Prices: Unchanged

CUSIP: ALMS: 022307102

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The ALMS component of ALMS1 exercise/assignment activity from May 21, 2025 through June 2, 2025, has settled through National Security Clearing Corporation (NSCC). The \$0.68 cash amount will be settled by OCC.

Pricing

The underlying price for ALMS1 will be determined as follows:

$$\text{ALMS1} = 0.48 (\text{ALMS}) + 0.0068$$

For example, if ALMS closes at 3.29, the ALMS1 price would be calculated as follows:

$$\text{ALMS1} = 0.48 (3.29) + 0.0068 = 1.59$$
