On June 26, 2025, Shareholders of SpringWorks Therapeutics, Inc. (SWTX) will vote concerning the proposed merger with EMD Holdings Merger Sub, Inc., a wholly owned subsidiary of Merck KGaA, Darmstadt, Germany. If the merger is approved and consummated, each existing SWTX Common Share will be converted into the right to receive \$47.00 net cash per share.

## Contract Adjustment

Date:Effective the opening of the business day after the merger is consummated.<br/>Contract adjustment is expected to occur in the second half of 2025.

## New Deliverable Per Contract: \$4,700.00 Cash (\$47.00 x 100)

Settlement in SWTX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
