RAPT Therapeutics, Inc. (RAPT) has announced a 1-for-8 reverse stock split. As a result of the reverse stock split, each RAPT Common Share will be converted into the right to receive 0.125 (New) RAPT Therapeutics, Inc. Common Shares. The reverse stock split will become effective before the market open on June 17, 2025. Cash will be paid in lieu of fractional RAPT shares.

$$\text{RAPT1} = 0.125 (\text{RAPT})$$

## **Delayed Settlement**

The RAPT component of the RAPT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the RAPT1 deliverable until the cash in lieu of fractional RAPT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
