## Subject: GraniteShares 1x Short AMD Daily ETF - Liquidation/Cash Settlement/Acceleration of Expirations Option Symbol: AMDS Date: 06/24/2025

On May 19, 2025, GraniteShares ETF Trust announced that it will terminate and subsequently liquidate the GraniteShares 1x Short AMD Daily ETF (AMDS). The last day of trading on NASDAQ Stock Market was June 20, 2025. Proceeds of the liquidation were distributed to shareholders in the amount of \$13.129096 per AMDS share on June 24, 2025.

## Contract Adjustment

The option symbol AMDS will not change.

AMDS options, which were subject to delayed settlement on June 23, 2025, are no longer subject to delayed settlement, effective June 24, 2025.

Settlement in AMDS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of GraniteShares 1x Short AMD Daily ETF options whose expiration dates are after 07-18-2025 will have their expiration dates advanced to 07-18-2025. Expiration dates occurring before 07-18-2025 (e.g., Flex options) will remain unchanged.

All GraniteShares 1x Short AMD Daily ETF options will utilize a \$.01 exercise threshold.

Option Symbol: AMDS Existing Expiration: All months New expiration date: 07-18-2025

Existing American-style GraniteShares 1x Short AMD Daily ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
