Solo Brands, Inc. (DTCB) has announced a 1-for-40 reverse stock split and symbol change to DTCBD. As a result, each DTCB Common Share will be converted into the right to receive 0.025 (New) Solo Brands, Inc. (DTCBD) Common Shares. The reverse stock split and symbol change will become effective before the market open on July 9, 2025. Cash will be paid in lieu of fractional shares.

Contract Adjustment

Effective Date: July 9, 2025

Option Symbol: DTCB changes to DTCB1

Contract Multiplier: 1

Strike Divisor: 1

New Multiplier: 100 (e.g., for premium or strike dollar extensions 1.00 will equal \$100)

- 1) 2 (New) Solo Brands, Inc. (DTCBD) Common Shares
- 2) Cash in lieu of 0.5 fractional DTCBD Shares

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for DTCB1 will be determined as follows:

$$\text{DTCB1} = 0.025 (\text{DTCBD})$$

Delayed Settlement

The DTCBD component of the DTCB1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the DTCB1 deliverable until the cash in lieu of fractional DTCBD Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
