**Subject:** Adjusted The AZEK Company Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: JHX1

Adjusted The AZEK Company Inc. options were adjusted on July 1, 2025 (See OCC Information Memo #56792). The new deliverable became 1) 103 James Hardie Industries plc (JHX) Ordinary Shares, 2) Cash in lieu of 0.4 fractional JHX shares, and 3) \$2,645.00 Cash. Only settlement of the cash portion of JHX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$26.053018 per whole JHX share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.4 \times \$26.053018 = \$10.42 \text{ per JHX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 1, 2025 through July 08, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the JHX1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 103 James Hardie Industries plc (JHX) Ordinary Shares  
2) \$2,655.42 Cash (\$2,645.00 + \$10.42)

**Strike Prices:** Unchanged

**CUSIP:** JHX: G4253H101

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The JHX component of JHX1 exercise/assignment activity from July 1, 2025 through July 7, 2025, has settled through National Security Clearing Corporation (NSCC). The \$2,655.42 cash amount will be settled by OCC.

## **Pricing**

The underlying price for JHX1 will be determined as follows:

$$\text{JHX1} = 1.03 (\text{JHX}) + 26.5542$$

For example, if JHX closes at 27.90, the JHX1 price would be calculated as follows:

$$\text{JHX1} = 1.03 (27.90) + 26.5542 = 55.29$$
