As a result of the reverse stock split, each GORV Common Share will be converted into the right to receive approximately 0.033333 (New) Lazydays Holdings, Inc. Common Shares. The reverse stock split will become effective before the market open on July 14, 2025. Fractional shares will be rounded up to the next whole share.
