On July 11, 2025, settlement of XAIR options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #56864). XAIR options became XAIR1 options on July 14, 2025 (see OCC Information Memo #56848).

Effective July 14, 2025, XAIR shares (CUSIP 08862L202) are eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for XAIR1 options as of July 14, 2025 will no longer be subject to broker to broker settlement. Exercise and assignment activity from July 14, 2025 and thereafter for XAIR1 options will settle through NSCC.

The deliverable for XAIR1 options contracts will remain the underlying 5 Beyond Air, Inc. Common Shares.
