**Pricing**

Until the cash in lieu amount is determined, the underlying price for SLB1 will be determined as follows:

$$\text{SLB1} = 0.735 (\text{SLB})$$

**Delayed Settlement**

The SLB component of the SLB1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SLB1 deliverable until the cash in lieu of

fractional SLB shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

### **Background**

On June 18, 2024, Shareholders of ChampionX Corporation (CHX) voted concerning the proposed merger with Schlumberger Limited (SLB). The merger was approved and subsequently consummated before the open on July 16, 2025. As a result, each existing CHX Common Share will be converted into the right to receive 0.735 SLB Common Shares. Cash will be paid in lieu of fractional SLB shares.
