Subject: Adjusted NextCure, Inc. - Cash in Lieu Settlement
Adjusted Option Symbol: NXTC1

Adjusted NextCure, Inc. options were adjusted on July 14, 2025 (See OCC Information Memo #56852). The new deliverable became 1) 8 NextCure, Inc. (NXTC) Common Shares and 2) Cash in lieu of approximately 0.3333 fractional NXTC Shares. Only settlement of the cash portion of NXTC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$4.74 per whole NXTC share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$4.74 = \$1.58 \text{ per NXTC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 14, 2025 through July 22, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NXTC1 options are as follows:

New Deliverable

Per Contract: 1) 8 NextCure, Inc. (NXTC) Common Shares
2) \$1.58 Cash

Strike Prices: Unchanged

CUSIP: NXTC: 65343E207

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The NXTC component of NXTC1 exercise/assignment activity from July 14, 2025 through July 21, 2025, has settled through National Security Clearing Corporation (NSCC). The \$1.58 cash amount will be settled by OCC.

Pricing

The underlying price for NXTC1 will be determined as follows:

$$\text{NXTC1} = 0.08 (\text{NXTC}) + 0.0158$$

For example, if NXTC closes at 4.98, the NXTC1 price would be calculated as follows:

$$\text{NXTC1} = 0.08 (4.98) + 0.0158 = 0.41$$
