**Subject:** Adjusted MicroAlgo, Inc. - Cash in Lieu Settlement  
Adjusted Option Symbol: MLGO1

Adjusted MicroAlgo, Inc. options were adjusted on July 18, 2025 (See OCC Information Memo #56886). The new deliverable became 1) 3 MicroAlgo, Inc. (MLGO) Class A Ordinary Shares and 2) Cash in lieu of approximately 0.3333 fractional MLGO Shares. Only settlement of the cash portion of MLGO1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$14.66 per whole MLGO share will be used to determine the cash in lieu amount at a rate of 0.3333. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$14.66 = \$4.89 \text{ per MLGO1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 18, 2025 through July 24, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the MLGO1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 3 MicroAlgo, Inc. (MLGO) Class A Ordinary Shares  
2) \$4.89 Cash

**Strike Prices:** Unchanged

**CUSIP:** MLGO: G6077Y400

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The MLGO component of MLGO1 exercise/assignment activity from July 18, 2025 through July 23, 2025, has settled through National Security Clearing Corporation (NSCC). The \$4.89 cash amount will be settled by OCC.

## **Pricing**

The underlying price for MLGO1 will be determined as follows:

$$\text{MLGO1} = 0.03 (\text{MLGO}) + 0.0489$$

For example, if MLGO closes at 14.43, the MLGO1 price would be calculated as follows:

$$\text{MLGO1} = 0.03 (14.43) + 0.0489 = 0.48$$
