Subject: Hess Corporation – Cash In Lieu Settlement
Adjusted Option Symbols: CVX1/2CVX1

Hess Corporation options were adjusted on July 18, 2025 (See OCC Information Memo #56907). The new deliverable became 1) 102 Chevron Corporation (CVX) Common Shares and 2) Cash in lieu of 0.5 fractional CVX shares. Only settlement of the cash portion of CVX1/2CVX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$149.01 per whole CVX share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$149.01 = \$74.51 \text{ per CVX1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 18, 2025 through July 25, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the CVX1/2CVX1 options are as follows:

New Deliverable

Per Contract: 1) 102 Chevron Corporation (CVX) Common Shares
2) \$74.51 Cash

Strike Prices: Unchanged

CUSIP: CVX: 166764100

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The CVX component of CVX1/2CVX1 exercise/assignment activity from July 18, 2025 through July 24, 2025, has settled through National Security Clearing Corporation (NSCC). The \$74.51 cash amount will be settled by OCC.

Pricing

The underlying price for CVX1/2CVX1 will be determined as follows:

$$\text{CVX1} = 1.02 (\text{CVX}) + 0.7451$$

For example, if CVX closes at 155.83, the CVX1/2CVX1 price would be calculated as follows:

$$\text{CVX1} = 1.02 (155.83) + 0.7451 = 159.69$$
