**Subject:** iCAD, Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: RDNT1

iCAD, Inc. options were adjusted on July 17, 2025 (See OCC Information Memo #56894). The new deliverable became 1) 6 RadNet, Inc. (RDNT) Common Shares and 2) Cash in lieu of 0.77 fractional RDNT shares. Only settlement of the cash portion of RDNT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$56.26 per whole RDNT share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.77 \times \$56.26 = \$43.32 \text{ per RDNT1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 17, 2025 through July 28, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the RDNT1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 6 RadNet, Inc. (RDNT) Common Shares  
2) \$43.32 Cash

**Strike Prices:** Unchanged

**CUSIP:** RDNT: 750491102

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The RDNT component of RDNT1 exercise/assignment activity from July 17, 2025 through July 25, 2025, has settled through National Security Clearing Corporation (NSCC). The \$43.32 cash amount will be settled by OCC.

## **Pricing**

The underlying price for RDNT1 will be determined as follows:

$$\text{RDNT1} = 0.06 (\text{RDNT}) + 0.4332$$

For example, if RDNT closes at 57.41, the RDNT1 price would be calculated as follows:

$$\text{RDNT1} = 0.06 (57.41) + 0.4332 = 3.88$$
