On May 25, 2025, the Principal Stockholders, which owned approximately 53.76% of the aggregate voting power of the issued and outstanding shares of E2open Parent Holdings, Inc. (ETWO), delivered written consent approving the merger agreement between ETWO and a wholly owned subsidiary of WiseTech Global Limited. If and when the merger is consummated, each existing ETWO Class A Common Share will be converted into the right to receive \$3.30 net cash per share.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the second half of 2025.

**New Deliverable
Per Contract:** \$330.00 Cash (\$3.30 x 100)

Settlement in ETWO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations
