Subject: Redfin Corporation – Cash In Lieu Settlement
Adjusted Option Symbol: RKT1

Redfin Corporation options were adjusted on July 1, 2025 (See OCC Information Memo #56795). The new deliverable became 1) 79 Rocket Companies, Inc. (RKT) Class A Common Shares and 2) Cash in lieu of 0.26 fractional RKT Class A Common Shares. Only settlement of the cash portion of RKT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$13.915 per whole RKT share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.26 \times \$13.915 = \$3.62 \text{ per RKT1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 1, 2025 through August 01, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the RKT1 options are as follows:

New Deliverable

Per Contract: 1) 79 Rocket Companies, Inc. (RKT) Class A Common Shares
2) \$3.62 Cash

Strike Prices: Unchanged

CUSIP: RKT: 77311W101

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The RKT component of RKT1 exercise/assignment activity from July 1, 2025 through July 31, 2025, has settled through National Security Clearing Corporation (NSCC). The \$3.62 cash amount will be settled by OCC.

Pricing

The underlying price for RKT1 will be determined as follows:

$$\text{RKT1} = 0.79 (\text{RKT}) + 0.0362$$

For example, if RKT closes at 14.77, the RKT1 price would be calculated as follows:

$$\text{RKT1} = 0.79 (14.77) + 0.0362 = 11.70$$
