Subject: ESSA Bancorp, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: CCNE1

ESSA Bancorp, Inc. options were adjusted on July 24, 2025 (See OCC Information Memo #56939). The new deliverable became 1) 85 CNB Financial Corporation (CCNE) Common Shares and 2) Cash in lieu of 0.47 fractional CCNE shares. Only settlement of the cash portion of CCNE1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$23.96 per whole CCNE share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.47 \times \$23.96 = \$11.26 \text{ per CCNE1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 24, 2025 through August 01, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the CCNE1 options are as follows:

New Deliverable

Per Contract: 1) 85 CNB Financial Corporation (CCNE) Common Shares
2) \$11.26 Cash

Strike Prices: Unchanged

CUSIP: CCNE: 126128107

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The CCNE component of CCNE1 exercise/assignment activity from July 24, 2025 through July 31, 2025, has settled through National Security Clearing Corporation (NSCC). The \$11.26 cash amount will be settled by OCC.

Pricing

The underlying price for CCNE1 will be determined as follows:

$$\text{CCNE1} = 0.85 (\text{CCNE}) + 0.1126$$

For example, if CCNE closes at 22.95, the CCNE1 price would be calculated as follows:

$$\text{CCNE1} = 0.85 (22.95) + 0.1126 = 19.62$$
