Spruce Biosciences, Inc. (SPRB) has announced a 1-for-75 reverse stock split and symbol change to SPRBD. As a result of the reverse stock split, each SPRB Common Share will be converted into the right to receive approximately 0.013333 (New) Spruce Biosciences, Inc. (SPRBD) Common Shares. The reverse stock split and symbol change will become effective before the market open on August 7, 2025. Cash will be paid in lieu of fractional shares.

Pricing

Until the cash in lieu amount is determined, the underlying price for SPRB1 will be determined as follows:

$$\text{SPRB1} = 0.013333 (\text{SPRBD})$$

Delayed Settlement

The SPRBD component of the SPRB1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SPRB1 deliverable until the cash in lieu of fractional SPRBD Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
