Subject: Uniti Group Inc. – Cash In Lieu Settlement
Adjusted Option Symbols: UNIT1/1UNIT1

Uniti Group Inc. options were adjusted on August 4, 2025 (See OCC Information Memo #57008). The new deliverable became 1) 60 Uniti Group Inc. (UNIT) Common Shares and 2) Cash in lieu of 0.29 fractional UNIT shares. Only settlement of the cash portion of UNIT1/1UNIT1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$8.09 per whole UNIT share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.29 \times \$8.09 = \$2.35 \text{ per UNIT1/1UNIT1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 4, 2025 through August 19, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the UNIT1/1UNIT1 options are as follows:

New Deliverable

Per Contract: 1) 60 Uniti Group Inc. (UNIT) Common Shares
2) \$2.35 Cash

Strike Prices: Unchanged

CUSIP: UNIT: 912932100

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The UNIT component of UNIT1/1UNIT1 exercise/assignment activity from August 4, 2025 through August 18, 2025, has settled through National Security Clearing Corporation (NSCC). The \$2.35 cash amount will be settled by OCC.

Pricing

The underlying price for UNIT1/1UNIT1 will be determined as follows:

$$\text{UNIT1} = 0.60 (\text{UNIT}) + 0.0235$$

For example, if UNIT closes at 6.25, the UNIT1/1UNIT1 price would be calculated as follows:

$$\text{UNIT1} = 0.60 (6.25) + 0.0235 = 3.77$$
