Delayed Settlement

The DNOW component of the DNOW1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the DNOW1 deliverable until the cash in lieu of fractional DNOW shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On September 9, 2025, Shareholders of MRC Global Inc. (MRC) will vote concerning the proposed merger with DNOW Inc. (DNOW). If the merger is approved and consummated, each existing MRC Common Share will be converted into the right to receive 0.9489 DNOW Common Shares. Cash will be paid in lieu of fractional DNOW shares.
