Subject: Sitio Royalties Corporation – Cash In Lieu Settlement
Adjusted Option Symbol: VNOM1

Sitio Royalties Corporation options were adjusted on August 19, 2025 (See OCC Information Memo #57085). The new deliverable became 1) 48 Viper Energy Inc. (VNOM) Class A Common Shares and 2) Cash in lieu of 0.55 fractional VNOM shares. Only settlement of the cash portion of VNOM1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$37.19 per whole VNOM share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.55 \times \$37.19 = \$20.45 \text{ per VNOM1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of August 19, 2025 through August 25, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the VNOM1 options are as follows:

New Deliverable

Per Contract: 1) 48 Viper Energy Inc. (VNOM) Class A Common Shares
2) \$20.45 Cash

Strike Prices: Unchanged

CUSIP: VNOM: 64361Q101

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The VNOM component of VNOM1 exercise/assignment activity from August 19, 2025 through August 22, 2025, has settled through National Security Clearing Corporation (NSCC). The \$20.45 cash amount will be settled by OCC.

Pricing

The underlying price for VNOM1 will be determined as follows:

$$\text{VNOM1} = 0.48 (\text{VNOM}) + 0.2045$$

For example, if VNOM closes at 38.99, the VNOM1 price would be calculated as follows:

$$\text{VNOM1} = 0.48 (38.99) + 0.2045 = 18.92$$
