On June 12, 2025, Shareholders of Dun & Bradstreet Holdings, Inc. (DNB) voted concerning the proposed merger with a wholly owned subsidiary of Denali Intermediate Holdings, Inc., which are both subsidiaries of certain investment funds managed by affiliates of Clearlake Capital Group L.P. The merger was approved and subsequently consummated before the open on August 26, 2025. As a result, each existing DNB Common Share will be converted into the right to receive \$9.15 net cash per share.

Settlement in DNB options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Dun & Bradstreet Holdings, Inc. options whose expiration dates are after 09-19-2025 will have their expiration dates advanced to 09-19-2025. Expiration dates occurring before 09-19-2025 (e.g., Flex options) will remain unchanged.

All Dun & Bradstreet Holdings, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Dun & Bradstreet Holdings, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
