FiscalNote Holdings, Inc. (NOTE) has announced a 1-for-12 reverse stock split. As a result of the reverse stock split, each NOTE Common Share will be converted into the right to receive approximately 0.083333 (New) FiscalNote Holdings, Inc. Common Shares. The reverse stock split will become effective before the market open on September 2, 2025. Cash will be paid in lieu of fractional shares.

Pricing

Until the cash in lieu amount is determined, the underlying price for NOTE1 will be determined as follows:

$$\text{NOTE1} = 0.083333 (\text{NOTE})$$

Delayed Settlement

The NOTE component of the NOTE1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the NOTE1 deliverable until the cash in lieu of fractional NOTE Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
