Effective on August 21, 2025, settlement of MAG options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #57120). MAG shares (CUSIP 55903Q104) are now eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for MAG options as of August 28, 2025 and thereafter for MAG options will no longer be subject to broker to broker settlement and will settle through NSCC.

Any existing broker to broker obligations from MAG exercise and assignment activity between August 21, 2025 and August 27, 2025, will remain subject to broker to broker settlement.

The deliverable for MAG options will remain the underlying 100 MAG Silver Corporation Common Shares.
