On July 31, 2025, Global X Management Company LLC announced that it will terminate and subsequently liquidate the Global X PropTech ETF (PTEC). The Fund ceased trading at the end of the trading day on August 22, 2025. The Fund is expected to liquidate on or around August 29, 2025. On or around the liquidation date, shareholders will receive a cash distribution equal to the net asset value of their shares.

Proceeds of the liquidation were distributed to shareholders in the amount of \$39.6445 per PTEC share on August 29, 2025.

Contract Adjustment

The option symbol PTEC will not change.

New Deliverable
Per Contract: \$3,964.45 Cash (\$39.6445 x 100)

PTEC options, which were subject to delayed settlement from August 25, 2025 through August 28, 2025, will no longer be subject to delayed settlement, effective August 29, 2025.

Settlement in PTEC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Global X PropTech ETF options whose expiration dates are after 09-19-2025 will have their expiration dates advanced to 09-19-2025. Expiration dates occurring before 09-19-2025 (e.g., Flex options) will remain unchanged.

All iShares Global X PropTech ETF options will utilize a \$.01 exercise threshold.

Existing Expiration: All months

New expiration date: 09-19-2025

Existing American-style Global X PropTech ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
