Effective on August 29, 2025, settlement of FL options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #57185). FL shares (CUSIP 344849104) are now eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for FL options as of September 2, 2025 and thereafter for FL options will no longer be subject to broker to broker settlement and will settle through NSCC.

Any existing broker to broker obligations on FL exercise and assignment on August 29, 2025 will remain subject to broker to broker settlement.

The deliverable for FL options will remain the underlying 100 Foot Locker, Inc. Common Shares.
