Clearside Biomedical, Inc. (CLSD) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each CLSD Common Share will be converted into the right to receive approximately 0.066667 (New) Clearside Biomedical, Inc. Common Shares. The reverse stock split will become effective before the market open on September 15, 2025. Cash will be paid in lieu of fractional shares.

Until the cash in lieu amount is determined, the underlying price for CLSD1 will be determined as follows:

$$\text{CLSD1} = 0.066667 \text{ (CLSD)}$$

Delayed Settlement

The CLSD component of the CLSD1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the CLSD1 deliverable until the cash in lieu of fractional CLSD Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
