Subject: Pacific Premier Bancorp, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: COLB1

Pacific Premier Bancorp, Inc. options were adjusted on September 2, 2025 (See OCC Information Memo #57191). The new deliverable became 1) 91 Columbia Banking System, Inc. (COLB) Common Shares and 2) Cash in lieu of 0.5 fractional COLB Common Shares. Only settlement of the cash portion of COLB1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$27.02 per whole COLB share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.5 \times \$27.02 = \$13.51 \text{ per COLB1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of September 2, 2025 through September 16, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the COLB1 options are as follows:

New Deliverable

Per Contract: 1) 91 Columbia Banking System, Inc. (COLB) Common Shares
2) \$13.51 Cash

Strike Prices: Unchanged

CUSIP: COLB: 197236102

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The COLB component of COLB1 exercise/assignment activity from September 2, 2025 through September 15, 2025, has settled through National Security Clearing Corporation (NSCC). The \$13.51 cash amount will be settled by OCC.

Pricing

The underlying price for COLB1 will be determined as follows:

$$\text{COLB1} = 0.91 (\text{COLB}) + 0.1351$$

For example, if COLB closes at 25.84, the COLB1 price would be calculated as follows:

$$\text{COLB1} = 0.91 (25.84) + 0.1351 = 23.65$$
