Effective on October 3, 2025, settlement of ARIS options exercise/assignment activity was subject to broker to broker settlement (see OCC Information Memo #57382). ARIS shares (CUSIP 04041L106) are now eligible for Continuous Net Settlement ("CNS") at the National Securities Clearing Corporation ("NSCC"). As a result, all exercise and assignment activity for ARIS options as of October 10, 2025 and thereafter for ARIS options will no longer be subject to broker to broker settlement and will settle through NSCC.

Any existing broker to broker obligations on ARIS exercise and assignment between October 3, 2025 and October 9, 2025 will remain subject to broker to broker settlement.

The deliverable for ARIS options will remain the underlying 100 Aris Water Solutions, Inc. Class A Common Shares.
