**Subject:** TELUS International (Cda) Inc. – Cash In Lieu Settlement  
Adjusted Option Symbol: TU1

TELUS International (Cda) Inc. options were adjusted on October 31, 2025 (See OCC Information Memo #57565). The new deliverable became 1) 13 TELUS Corporation (TU) Common Shares, 2) Cash in lieu of 0.6 fractional TU shares, and 3) \$225.00 Cash. Only settlement of the cash portion of TU1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$16.49 per whole TU share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.6 \times \$16.49 = \$9.89 \text{ per TU1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of October 31, 2025 through November 13, 2025, to deliver the appropriate cash amount.

**The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.**

Terms of the TU1 options are as follows:

**New Deliverable**

**Per Contract:** 1) 13 TELUS Corporation (TU) Common Shares  
2) \$234.89 Cash (\$225.00 + \$9.89)

**Strike Prices:** Unchanged

**CUSIP:** TU: 87971M103

**Multiplier:** 100 (i.e., a premium of 1.50 yields \$150)

**Settlement**

The TU component of TU1 exercise/assignment activity from October 31, 2025 through November 12, 2025, has settled through National Security Clearing Corporation (NSCC). The \$234.89 cash amount will be settled by OCC.

## **Pricing**

The underlying price for TU1 will be determined as follows:

$$\text{TU1} = 0.13 (\text{TU}) + 2.3489$$

For example, if TU closes at 14.67, the TU1 price would be calculated as follows:

$$\text{TU1} = 0.13 (14.67) + 2.3489 = 4.26$$
