Netflix, Inc. (NFLX) has announced a 10 for 1 stock split. **The amendment to the Company's Amended and Restated Certificate of Incorporation was filed on November 14, 2025.** The Ex-distribution Date is November 17, 2025. The Payable Date is November 14, 2025. The Record Date is November 10, 2025.
