On May 26, 2025, the lead investors, which owned approximately 63% of the aggregate voting power of the issued and outstanding shares of Informatica Inc. (INFA), delivered written consent approving the merger agreement between INFA and a wholly owned subsidiary of Salesforce, Inc. The merger was subsequently consummated before the open on November 18, 2025. As a result, each existing INFA Class A Common Share will be converted into the right to receive \$25.00 net cash per share.

Per Contract:** \$2,500.00 Cash (\$25.00 x 100)

Settlement in INFA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Informatica Inc. options whose expiration dates are after 11-21-2025 will have their expiration dates advanced to 11-21-2025. Expiration dates occurring before 11-21-2025 (e.g., Flex options) will remain unchanged.

All Informatica Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 11-21-2025

Existing Informatica Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
