Subject: Berry Corporation – Cash In Lieu Settlement
Adjusted Option Symbol: CRC1

Berry Corporation options were adjusted on December 18, 2025 (See OCC Information Memo #57947). The new deliverable became 1) 7 California Resources Corporation (CRC) Common Shares, and 2) Cash in lieu of 0.18 fractional CRC shares. Only settlement of the cash portion of CRC1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$47.21 per whole CRC share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.18 \times \$47.21 = \$8.50 \text{ per CRC1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of December 18, 2025 through December 26, 2025, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the CRC1 options are as follows:

New Deliverable

Per Contract: 1) 7 California Resources Corporation (CRC) Common Shares
2) \$8.50 Cash

Strike Prices: Unchanged

CUSIP: CRC: 13057Q305

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The CRC component of CRC1 exercise/assignment activity from December 18, 2025 through December 24, 2025, has settled through National Security Clearing Corporation (NSCC). The \$8.50 cash amount will be settled by OCC.

Pricing

The underlying price for CRC1 will be determined as follows:

$$\text{CRC1} = 0.07 (\text{CRC}) + 0.0850$$

For example, if CRC closes at 44.04, the CRC1 price would be calculated as follows:

$$\text{CRC1} = 0.07 (44.04) + 0.0850 = 3.17$$
