Adjusted Tradr 2X Long TEM Daily ETF options were adjusted on December 23, 2025 (See OCC Information Memo #58005). The new deliverable became 1) 100 Tradr 2X Long TEM Daily ETF (TEMT) Shares and 2) \$384.75 Cash.

Tradr 2X Long TEM Daily ETF (TEMT) has announced a 1-for-3 reverse stock split. As a result of the reverse stock split, each TEMT Share will be converted into the right to receive approximately 0.333333 (New) Tradr 2X Long TEM Daily ETF Shares. The reverse stock split will become effective before the market open on March 10, 2026. Cash will be paid in lieu of fractional shares.

Adjusted TEMT1 options will be further adjusted to reflect the reverse split as described below:

Contract Adjustment

Effective Date: March 10, 2026

Option Symbol: TEMT1 remains TEMT1

Contract Multiplier: 1

Strike Divisor: 1

New Multiplier: 100 (e.g., for premium or strike dollar extensions 1.00 will equal \$100)

New Deliverable Per Contract:

- 1) 33 (New) Tradr 2X Long TEM Daily ETF (TEMT) Shares
- 2) Cash in lieu of approximately 0.3333 fractional TEMT Shares
- 3) \$384.75 Cash

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

CUSIP: TEMT (New): 46152A445

Pricing

Until the cash in lieu amount is determined, the underlying price for TEMT1 will be determined as follows:

$$\text{TEMT1} = 0.333333 (\text{TEMT}) + 3.8475$$

Delayed Settlement

The TEMT component of the TEMT1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the TEMT1 deliverable until the cash in lieu of fractional TEMT Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
