On March 9, 2026, Shareholders of Alexander & Baldwin, Inc. (ALEX) voted concerning the proposed merger with a wholly-owned subsidiary of Tropic Purchaser LLC, a joint venture investor group affiliated with MW Group, Ltd., Blackstone Real Estate, and DivcoWest Real Estate Services, LLC. The merger was approved and subsequently consummated on March 12, 2026. As a result, each existing ALEX Common Share will be converted into the right to receive \$20.85 (\$21.20 cash consideration less the \$0.35 quarterly dividend ("January dividend" as defined in the ALEX Proxy Statement dated January 23, 2026) net cash per share.

Settlement in ALEX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Alexander & Baldwin, Inc. options whose expiration dates are after 03-20-2026 will have their expiration dates advanced to 03-20-2026. Expiration dates occurring before 03-20-2026 (e.g., Flex options) will remain unchanged.

All Alexander & Baldwin, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Alexander & Baldwin, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
