Subject: Adjusted Enviri Corporation – Cash In Lieu Settlement
Adjusted Option Symbol: NVRI1

Adjusted Enviri Corporation options were adjusted on June 1, 2026 (See OCC Information Memo #59084). The new deliverable became 1) 33 Enviri Corporation (NVRI) Common Shares, 2) Cash in lieu of approximately 0.3333 fractional NVRI Common Shares, and 3) \$1,500.00 Cash. Only settlement of the cash portion of NVRI1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$19.02 per whole NVRI share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.3333 \times \$19.02 = \$6.34 \text{ per NVRI1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 1, 2026 through June 12, 2026, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the NVRI1 options are as follows:

New Deliverable

Per Contract: 1) 33 Enviri Corporation (NVRI) Common Shares
2) \$1,506.34 Cash (\$1,500.00 + \$6.34)

Strike Prices: Unchanged

CUSIP: NVRI: 29390K102

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The NVRI component of NVRI1 exercise/assignment activity from June 1, 2026 through June 11, 2026, has settled through National Security Clearing Corporation (NSCC). The \$1,506.34 cash amount will be settled by OCC.

Pricing

The underlying price for NVRI1 will be determined as follows:

$$\text{NVR11} = 0.33 (\text{NVRI}) + 15.0634$$

For example, if NVRI closes at 21.13, the NVR11 price would be calculated as follows:

$$\text{NVR11} = 0.33 (21.13) + 15.0634 = 22.04$$
