On July 8, 2026, Shareholders of Catalyst Pharmaceuticals, Inc. (CPRX) will vote concerning the proposed merger with Angelini Cielo Inc., a wholly-owned subsidiary of Angelini Pharma S.p.A. If the merger is approved and consummated, each existing CPRX Common Share will be converted into the right to receive \$31.50 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the third quarter of 2026.

**New Deliverable  
Per Contract:** \$3,150.00 Cash (\$31.50 x 100)

Settlement in CPRX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
