On May 20, 2026, REX ETF Trust announced that it will terminate and subsequently liquidate the REX CRWV Growth & Income ETF (CWII). The last day of trading of CWII shares on the Cboe BZX Exchange, Inc. will be June 9, 2026.

On or around June 16, 2026, shareholders will have their shares redeemed for cash proceeds based on the net asset value of CWII share.

OCC has been informed that the liquidation proceeds were distributed to CWII shareholders on June 18, 2026, in the amount of \$12.77152359 per CWII share.

Contract Adjustment

The option symbol CWII will not change.

**New Deliverable
Per Contract:** \$1,277.15 Cash (\$12.77152359 x 100)

CWII options, which were subject to delayed settlement from June 10, 2026 to June 17, 2026, will no longer be subject to delayed settlement, effective June 18, 2026. Settlement in CWII options will take place through OCC's cash settlement system.

Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of REX CRWV Growth & Income ETF options whose expiration dates are after 07-17-2026 will have their expiration dates advanced to 07-17-2026. Expiration dates occurring before 07-17-2026 (e.g., Flex options) will remain unchanged.

All REX CRWV Growth & Income ETF options will utilize a \$.01 exercise threshold.

Option Symbol: CWII

Existing Expiration: All months

New expiration date: 07-17-2026

Existing American-style REX CRWV Growth & Income ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
