On May 28, 2026, ETF Opportunities Trust announced that it will terminate and subsequently liquidate the REX-Osprey ETH + Staking ETF (ESK). The last day of trading of ESK shares on Cboe BZX Exchange, Inc. will be June 11, 2026.

On or about June 18, 2026 (the "Liquidation Date"), the Fund will cease operations, liquidate its assets, and prepare to distribute proceeds to shareholders of record as of the Liquidation Date. Any remaining ESK Shareholders of record will receive a distribution of their remaining investment value in ESK.

OCC has been informed that the liquidation proceeds were distributed to ESK shareholders on June 23, 2026, in the amount of \$11.06658523 per ESK share.

Contract Adjustment

The option symbol ESK will not change.

**New Deliverable
Per Contract:** \$1,106.66 Cash (\$11.06658523 x 100)

ESK options, which were subject to delayed settlement from June 12, 2026 to June 22, 2026, will no longer be subject to delayed settlement, effective June 23, 2026. Settlement in ESK options will take place through OCC's cash settlement system.

Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of REX-Osprey ETH + Staking ETF options whose expiration dates are after 07-17-2026 will have their expiration dates advanced to 07-17-2026. Expiration dates occurring before 07-17-2026 (e.g., Flex options) will remain unchanged.

All REX-Osprey ETH + Staking ETF options will utilize a \$.01 exercise threshold.

Option Symbol: ESK

Existing Expiration: All months

New expiration date: 07-17-2026

Existing American-style REX-Osprey ETH + Staking ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in one business day.
