Adjusted Fomento Economico Mexicano, S.A.B. de C.V. (adjusted option symbol FMX4) options were adjusted on April 22, 2026 (See OCC Information Memo #58908). The new deliverable became 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) \$103.96 Cash.

Fomento Economico Mexicano, S.A.B. de C.V. (FMX) has announced an Extraordinary Cash Dividend of approximately \$0.677649, less fees and withholdings, if any, per FMX American Depositary Share. The record date is July 15, 2026; payable date is July 27, 2026. The ex-distribution date for this distribution will be July 15, 2026.

Adjusted Fomento Economico Mexicano, S.A.B. de C.V. options will be further adjusted as described below:

Pricing

Until the final net cash dividend amount is determined, the underlying price for FMX4 will be determined as follows:

$$\text{FMX4} = \text{FMX} + 1.7172$$

Delayed Settlement

The FMX component of the FMX4 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FMX4 deliverable until the exact cash amount is determined. Upon determination of the exact cash amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
