Adjusted Fomento Economico Mexicano, S.A.B. de C.V. (adjusted option symbol FMX3) options were adjusted on January 16, 2026 and again on April 22, 2026 (See OCC Information Memos #58262 and #58909). The new deliverable became 1) 100 Fomento Economico Mexicano, S.A.B. de C.V. (FMX) American Depositary Shares and 2) \$232.85 Cash.

Fomento Economico Mexicano, S.A.B. de C.V. (FMX) has announced an Extraordinary Cash Dividend of approximately \$0.677649, less fees and withholdings, if any, per FMX American Depositary Share. The record date is July 15, 2026; payable date is July 27, 2026. The ex-distribution date for this distribution will be July 15, 2026.

Adjusted Fomento Economico Mexicano, S.A.B. de C.V. options will be further adjusted as described below:

Until the final net cash dividend amount is determined, the underlying price for FMX3 will be determined as follows:

$$\text{FMX3} = \text{FMX} + 3.0061$$

Delayed Settlement

The FMX component of the FMX3 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FMX3 deliverable until the exact cash amount is determined. Upon determination of the exact cash amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
